## PART-I

Handbook for Returning Officers and Presiding Officers at Election to Village Councils under Chakma Autonomous District Council

(English)

#### **RETURNING OFFICER**

This handbook provides you the basic information and guidance for the Returning Officer for Election to Village Councils under the Chakma Autonomous District Council, which is, however, neither an exhaustive compendium in all aspects nor a substitute for the provisions and the relevant laws. If there is any doubt arises, you may consult the Chakma Autonomous District Council (Election to Village Council) Rules 2007 as amended in 2013 (Annexure-II)

#### I. FIRST THINGS TO DO

- 1. Read this Handbook carefully and thoroughly to know your duties and responsibilities. You must be well conversant with the Handbook.
- 2. Check the Election Materials that you have received and ensure whether the materials are in good condition and similar with the list provided to you. The safe custody of the materials will be your sole responsibilty. List of materials to be supplied to you by the DEO are listed at Annexure-I.
- Whenever necessary, you can detail the Village Crier with due intimation to the concerned Village Council for wide publicity of Election related information to the public.
- 4. It is your duty to instruct candidates and the political parties to comply with the provisions under the Model Code of Conduct issued by the Commission.

#### II. FILING AND SCRUTINY OF NOMINATIONS

- 5. Notice of Election in **Form-I** shall be issued by you in accordance with the Schedule of Election issued by the **State Election Commission**. You must widely publicize the election matter in detail through the Village Crier, the place of nomination to be filed should be identified by you.
- 6. You must supply the Nomination Form of Candidate in Form 2 and Form 2A. Candidates of Recognized Political Party shall be informed to submit Form-2A as a token of authenticity of candidature duly sponsored by the Recognised Political Parties. Inform them the date fixed for submission of nomination papers. Prepare a list of nomination papers received in Form 2B and the date, time and place for Scrutiny should be informed to all candidates.
- 7. A receipt of Nomination Form should be acknowledged in **Form 3** and its counterfoil must be given to the candidates. Make a detailed record in **Form 3A**.
- 8. You must scrutinize the Nomination Papers of the candidate on the fixed date and time in accordance with Section 4 of the Chakma Autonomous District Council (Village Council) Act, 2003 as follows:-

A candidate shall be disqualified -

- (a) If he is not a member of Scheduled Tribe.
- (b) If he is not a citizen of India.
- (c) If he is not a voter in respect of the village where he seeks election.
- (d) If he has not attained the age of 25 years.
- (e) If he is a member of any other Village Council.
- (f) If he is of unsound mind and stands so declared by Competent Court or authorities.
- (g) If he has been convicted an offence under the existing law of the Chakma Autonomous District Council or under any law for the time being in force in India, unless a period of three years has elapsed since his conviction and if imprisoned, since his release from prison.

If such candidates are disqualified on the grounds mentioned above, the Security Deposit must be refunded. Make a record as "Disqualified and Refunded" in the Part B of Form 3 and make entry in Form 3A, "Account of Security Deposit", accordingly.

9. Withdrawal of Candidature: Any contesting candidate desirous to withdraw their candidature before or after scrutiny, they must use Form 4 (Rule 13). For authentication of their withdrawal, Receipt for Notice of Withdrawal must be handed over to the person delivering the notice alongwith the 'Receipt of Security Deposit, and release Security Deposit'. Make a record of refund in Form 3 and 3A and make entry 'Withdrawn and Refunded' at 'How to disposed of'. After doing all the above, you must obtain the receipt in Form – 4A.

If any candidates forfeit their Security Deposit, you must deposit all such money to the **Local Administration Officer** in **Form 4B** and obtain the Receipt from him.

10. On completion of the Scrutiny of the Nomination Papers, you must examine the symbols chosen by the candidates forthwith. A **Reserved Symbol** shall be allotted to the Candidates sponsored by Recognized State and National Political Parties.

If same symbol is chosen by more than one independent candidates, allotment shall be done by lot.

SI. No. 3. Tokya (Hat), having been allotted as a Reserved Symbol for Zoram People's Movement Party (ZPM) Party as a Reserved Symbol by the Election Commission of India, it should only be allotted for ZPM Party, even if the Rules listed the symbol among other Free Symbols. Likewise, SI No. 23. Booi (Book) is also allotted for National People's Party (NPP).

11. All details in respect of the candidates like Symbol allotted, address and Political Party affiliations, if any, shall be prepared in Form-5 clearly indicating the commencement of Poll with end of Poll as fixed by State Election Commission.

Any mistake shall not be committed while filling up of Form-5 since the Ballot Paper will be printed as per the record of the Form.

- 12. If the number of validly nominated candidates are equal to the number of seats to be filled, you shall forthwith declare all such candidates to be elected to those seats in the Village Council uncontested.
- 13. If the number of valid candidates is less than the number of seats to be filled, you shall declare all such candidates to have been duly elected unopposed. The remaining uncontested seat(s) shall be filled up as per the direction of State Election Commission.

You must not, in any circumstances, invite the Candidates to equalize the number of seats to be filled up and Schedule of Election should not be altered without the permission of the Commission.

14. Each candidate shall appoint one Election Agent to represent himself which shall be done in Form 6, who shall be admitted into the Polling Booth in case of the Candidate absenting himself from the Polling Station.

#### III. COUNTING OF VOTES

#### 15. SUB VILLAGE:

At certain areas, there can be sub-village in a Village Council Constituency and since only one Returning Officer is appointed in a Village Council Constituency, votes should be counted in the Parent Village. In such cases, Ballot Box should be carefully sealed in the presence of candidates or their Agents and send to the Parent Village where votes are to be counted.

16. You must thoroughly go through Rule 30-34 of the Chakma Autonomous District Council (Election to Village Councils) Rules, 2007 as amended in 2013 and strictly follow the procedures. You must appoint a reliable persons as Counting Official as far as possible, the government employees, to assist you. In any case, a person with having any political party affiliation or engage in any political activities shall not be appointed as Counting Official.

#### 17. COUNTING SHEET:

To speed up counting of votes, counting tables as many as possible shall be arranged as votes are to be counted in round-wise, and make record in **Form 13**. At every round 50 Ballot papers shall be counted at one table.

Collect the counted votes from every counting table and make entry in **Form 13A** 'Counting Table Wise Results Tabulation Sheet'. The total votes obtained by every candidate in every round shall be entered in **Form 13B** 'Round Wise Tabulation Sheet'.

A separate table shall be provided for Tabulators. In the tally Method, a column of Round Wise Counting Sheet, votes obtained by every candidate should be marked in roman numerical 'l' four times, and the fifth votes shall be marked across and so on, in such column.

#### 18. Invalid Votes

#### The following shall be invalid votes:-

- i) If the ballot paper is not marked with arrow cross.
- ii) If arrow cross is marked more than the candidates listed in the ballot paper.
- iii) If other material other than arrow cross marked is used.
- iv) If the arrow cross marked is put half marked, each in between the line of candidates.
- v) If arrow cross is marked on the back side of ballot papers.

#### 19. Valid Votes

- i) If arrow cross is marked equal to the no. of candidates.
- ii) Even if arrow cross is marked less than the no. of candidates.
- iii) If arrow cross is marked in between the line of two candidates but the marked had clearly indicate more than half of the arrow mark shall be valid to whom the larger marked indicated.
- iv) Even if arrow cross is marked more than one within the boundary line of the particular candidate.

- v) Even if the mark is not clear.
- vi) Even if the arrow cross mark appeared on some little portion of the Ballot Paper.
- vii) Due to folding of Ballot Paper width-wise, the mark could appear at the other side within the boundary line of other candidate's symbol but arrow cross-mark appeared anti-clock wise. In that event, the original mark which appears clock wise will be valid.
- 20. In the case of multiple Election, declare the candidates who polled the highest votes in descending order as elected according to the no. of seats to be filled up. Prepare the result in **Form 15 Result Sheet** and send to the Secretary, State Election Commission and District Election Officer without delay.

'Certificate of Election' shall be prepared in Form 16 and be given to the elected candidate.

- 21. In accordance with Rule 16 of the Chakma Autonomous District Council (Election to Village Councils) Rules, 2007 as amended in 2013, the Security Deposits of any candidate who does not secure more than one-sixth (1/6) of the total votes polled shall forfeit to the District Council. The money so forfeited be deposited to the Local Administration Officer. Make entry in Form 3A 'How disposed of' as 'Forfeited'.
- 22. The forfeited Security Deposit with **Form 3A** shall be kept in one envelope which shall be sealed in Adhesive and Sealing Wax.
- 23. All valid votes of Ballot Papers containing valid votes shall be kept in one envelope which should be sealed in adhesive and sealing wax, write name of candidates with their secured votes, name of village, and Constituency Number on the cover which should be sent to the District Election Officer/Asst. District Election Officer for their safe custody.

All invalid votes shall also be kept in one envelope which shall also be sealed with adhesive and sealing wax. Write number of invalid votes, name of Village and Constituency Number in the cover which should be sent to District Election Officer/Asst. District Election Officer for their safe custody.

In Form 14 – Ballot Paper Account, all details about Ballot Paper polled in the Ballot Box, total valid Ballot Papers, total invalid Ballot Papers should clearly be indicated. Following the introduction of Common Ballot Paper, there shall be more than one votes in one Ballot paper. Do not get confused the Ballot Paper and Votes.

- 24. Spoilt Ballot Paper, Unused Ballot Paper, Ballot Paper Counterfoil shall be separately kept in separate envelope which should be sealed in adhesive sealing wax.
- 25. Refund the Security Deposit to the Elected Candidates and Unforfeited Candidates. Make entry in **Form-3A** and obtain their signature on the column-**signature of persons receiving refund**, and make record '**refunded**' in 'how disposed of'.

#### IV. OTHER IMPORTANT THINGS

- 26. During the Election process, no person shall interfere with your performance of duties and resposibilities as a Returning Officer. In the event of such untoward incident, Deputy Commissioner, Police or Election Authority should be informed immediately. You can take necessary action under Rule 43 of Chakma Autonomous District Council (Election to Village Councils) (Amendment) Rules, 2013.
- 27. If there is any complaint on 'Corrupt Practices' as provided under Rule 38 of Chakma Autonomous District Council (Election to Village Councils) (Amendment) Rules, 2013, you may refer Rule 36 ibid. Don't get confused yourself.
- 28. Ensure that sufficient copies of all kind of Forms to be used in Election are obtained from Election Office and make available for the Election.
- 29. In order to ensure smooth conduct of Election, it is the duty and responsibility of the Returning Officer and Presiding Officer, and the decision taken by them in their respective role shall also be final.

#### PRESIDING OFFICER

Guidelines of duty of Presiding Officer for Election to Village Council under Chakma Autonomous District Council is mentioned below. Read carefully, if you have any doubts please refer to Chakma Autonomous District Council (Election to Village Council) Rules, 2007 as amended in 2013 (Annex – II) and remember that this handbook is only for guidance.

#### I. Things you have to do first and foremost.

- 1. Read this Handbook carefully and thoroughly to know your duties and responsibilities. You must be well conversant with the Handbook.
- 2. Check the Election Materials that you have received and ensure whether the materials are in good condition and similar with the list provided to you. The safe custody of the materials will be your sole responsibilty. List of materials to be supplied to you by the DEO are listed at **Annexure-I**.
- 3. As Presiding Officer and Polling Officers are expected to be working together as a team, it is your duty to ensure that all are present at all times during the poll process.
- 4. You can appoint a substitute Polling Officer in case any Polling Officer appointed by State Election Commission could not perform his duty due to sickness or death. But you cannot appoint a candidate, an agent or any Political Party leaders as a Polling Officer. You should appoint a Government servant as far as possible.
- 5. You can utilise the service of any Village Crier on Election related matters under intimation to the Village Council concerned.
- 6. It is your duty to instruct candidates and the political parties to comply with the provisions under the Model Code of Conduct issued by the Commission.

#### II. Your Duties before the commencement of Poll.

- 7. You should make all necessary arrangement for the Polling Station before Poll Day and ensure that Seats of Presiding Officer, Polling Officers, candidates/Polling Agents and Ballot Box are ready before the poll commences.
- 8. The Voting Compartment should be located at sufficient distance from the view of Polling Officials to ensure secrecy of voting is not violated. It must be placed away from the window/door.
- 9. 'POLLING AREA', which should not be disturbed by the general public, be identified and notified. If the Polling Station Building has boundary fencing, the area covered could be regarded as Polling area. It is your duty to make sure that 'POLLING AREA' sign is put up.

- 10. Make sure and check that the Polling Station is ready on the evening before the date of Poll, lock up the rooms of the Poll Station building and make sure that the keys of the locks are kept by you.
- 11. On the night before the date of Poll, Public announcement should be made on the following
  - a) Name of Candidate, Party and Symbol.
  - b) Place of Poll/Polling Station.
  - c) Date and time of Poll.
  - d) No Public Meetings on the date of Poll.
  - e) No Public Meetings/ Campaigns should be held 24 hours before the date of Poll.
- 12. List of Contesting Candidates their symbols, address and name of Political Parties prepared by the Returning Officer in **Form 5** should be displayed. Election Agent appointed by Candidates duly approved by the Returning Officer should be allowed to sit inside the Polling Booth.
- 13. It is mandatory that **Form 5** should be displayed on the Polling Station Building or wherever available.

#### III. Ballot Box

- 14. Single Ballot Box shall be used and the size of ballot box shall be decided depending on the no. of voters. Demonstration of empty ballot box should be done in the presence of the Candidates and their agent half an hour before polling commences. If the candidates and their agents are satisfied the Ballot Box should be sealed with adhesive and sealing wax.
- 15. Presiding Officer and Polling Officers are to make sure that they reach the Polling Station 1 (one) hour before the Poll starts. Candidates and their agents are to be informed to be present an hour before the Poll time and they should be present at the time when the ballot box is prepared and make sure that it is empty and sealed, and they should append their signature wherever required.

If they do not arrive on time, demonstration should be done in the presence of the candidates and their agents who arrived on time. Time of commencement of Poll should not be deffered just because some Candidates or Agents are absent.

#### IV. Electoral Rolls

- 16. Separate Electoral Roll are prepared for Village Council Election as modified under Chakma Autonomous District Council (Election to Village Council) Rules, 2007. If there is any deletion of voters on the Electoral Roll, initial of Electoral Registration Officer/ Assistant Electoral Registration Officer should be made, and there should be no other deletion or correction made. If there is any other addition or deletion made by the Authority, it should be attached at the end of the Electoral Roll. You should make sure that the Candidate or his Agents are present and show them that there are no deletions/ corrections on the Electoral Rolls other than those mentioned above.
- 17. A copy of 1 (one) Electoral Roll should be lent to all Contesting Political Party Agents and make sure that you collect them back. You should inform the Political Parties clearly not to tamper with the Electoral Rolls and you have to make sure that no person can any way cast vote who has been deleted and not included in the Electoral Rolls.

18. Make a tick mark on the names of voters who had cast their votes on the Electoral Roll used for official copy. There should be no other marks other that this 'tick mark'.

#### V. Ballot Paper

- 19. a) Only 1 (one) Ballot Paper should be given. Ballot paper is designed to be separated in the middle and Rubber Stamp with Distinguishing mark 'Village Council' should marked on both side of area where it is to be perforated.
  - b) No. of voters should be entered in the SI. No. Column. E.g. first voter should be entered as No. 1, second voter as No. 2 and so on.
  - c) In addition to name of Village Council Constituency, Village Council Constituency No. should also be written on the column assigned for the Village No.
  - d) Ballot paper should be issued in sequencial order. After one book is fully used a new book should be opened and if there is a torn or damaged page it should be cancelled and should not be used. On the cover of the used copy, serial no should be made. E.g. 1-20, 21-40 and so on.
  - e) In order to make easy for voters to identify their choice of candidates, all the names of candidates should be arranged in alphabetical order on the ballot paper.
  - f) Deputy Commissioner/ District Election Officer are given the authority to print the Ballot paper and no one can complain how the papers are printed.
  - g) One book of Ballot paper usually contains 100 pages and if there is any page missing, make sure that the Candidates and their Agents are present and known by them and as far as possible, their signatures should be obtained.
  - h) **Form 7** is a Ballot Paper Sample, as directed under Rule 25 of the Chakma Autonomous District Council (Election to Village Council) Rules, 2007 as amended in 2013, only one ballot paper is to be issued to one voter. Demonstration on how they should mark a ballot paper with an arrow crossmark should done.
- 20. **Form 8** 'Register of Voters' is for registration of voters and signature/ thumb impression of the voters is to be obtained. The no. of votes polled and the no. of voters recorded in the register should be tallied with each other. In order to avoid mistake, one Polling Officer should be specifically instructed.
- 21. Please read carefully the instructions and your duty on poll day as spelled out under Rule 19-29 of the Chakma Autonomous District Council (Election to Village Council) Rules, 2007 as amended in 2013. Ensure that Distinguishing Mark are kept confidential. If a Voter does not want to cast his vote and returned the ballot paper, the same should be cancelled forthwith and the counterfoil should be marked as 'Refused' as provided under Rule 25 of the Chakma Autonomous District Council (Election to Village Council) Rules, 2007 as amended in 2013.
- 22. Voters should cast their vote during the period fixed for poll. In order to avoid gap, you should instruct the Village Council to make announcement to call the public to cast their vote during the hours fixed for polling. Polling Booth should not be closed before closing time. Some voters who has entered the Polling area before the time fixed for poll but has not yet cast their vote should be allowed to cast their vote. But you should be very careful that they are not mixed up with other voters, you should specifically separate them by issuing a slip of paper bearing your signature and seal and give a number and close the Polling Area immediately.

- 23. **Form 9** Ballot Paper Account of Presiding Officer should be prepared immediately after closing of poll and should be submitted to the Returning Officer before counting of votes and District Election Officer/Assistant District Election Officer should also be given. **Form 10 Presiding Officers' Diary** is also to be prepared and submitted to the Returning Officer and District Election Officer/Assistant District Election Officer. This diary should be prepared carefully so that even when there is an Election Petition this Diary is an important documentary proof.
- 24. The counterfoil of the ballot paper should be kept in a bundle and No. and Name of Village Council should be written and sealed with a sealing wax. When there is an Election Petition, this document is important and should be sent to the District Election Officer/ Assistant District Election Officer for safe custody. Similarly, the spoilt Ballot paper, unused ballot paper and counterfoil of ballot paper should be kept in separate envelope each and sent to District Election Officer/ Assistant District Election Officer for safe custody.

#### VI. Blind and infirm voters

- 25. As provided under Rules 26 of the Chakma Autonomous District Council (Election to Village Council) Rules, 2007 as amended in 2013 all blind and infirm voters should be specifically recorded in Form 11. A blind and infirm voter can cast his vote through a companion of not less than 18 years of age provided that no person shall be permitted to act as the companion of more than one elector at any polling station on the same day.
- 26. **SUB-VILLAGE**: At certain areas, there can be sub-village in a Village Council Constituency and since only one Returning Officer is appointed in a Village Council Constituency, votes should be counted in the Parent Village. In such cases, Ballot Box should be carefully sealed in the presence of candidates or their Agents and send to the Parent Village where votes are to be counted.

#### VII. Others

- 27. Ensure that sufficient copies of all kind of Forms to be used in Election are obtained from Election Office and make available for the Election.
- 28. The election materials received by you viz. Electoral Roll, Arrow Cross-Mark, Rubber Stamp, Distinguishing Mark, Flat Ruler, Stamp pad, Ballot Box, Indelible Ink and any other materials should be returned.
- 29. During the Election process, no person shall interfere with your performance of duties and resposibilities as a Returning Officer. In the event of such untoward incident, Deputy Commissioner, Police or Election Authority should be informed immediately. You can take necessary action under Rule 41-42 of Chakma Autonomous District Council (Election to Village Councils) (Amendment) Rules, 2013.
- 30. If there is any complaint on 'Corrupt Practices' as provided under Rule 38 of Chakma Autonomous District Council (Election to Village Councils) (Amendment) Rules, 2013, you may refer Rule 36 ibid. Don't get confused yourself.
- 31. In order to ensure smooth conduct of Election, it is the duty and responsibility of the Returning Officer and Presiding Officer, and the decision taken by them in their respective role shall also be final.

## PART-II

Handbook for Returning Officers and Presiding Officers at Election to Village Councils under Chakma Autonomous District Council

## CHAKMA AUTONOMOUS DISTRICT COUNCIL (Election to Village Councils) Rules, 2007.

In exercise of power conferred under section 29 of the Chakma Autonomous District Council (Village Councils) Act, 2003 the Executive Committee of the Chakma Autonomous District Council is pleased to make the following Rules with prior approval from the Governor of Mizoram.

### CHAPTER-I PRELIMINARY

#### 1. SHORT TITLE, EXTEND & COMMENCEMENT:

- (1) These Rules may be called the Chakma Autonomous District Council (Election to Village Councils) Rules 2007 as amended in 2013;
- (2) They extend to the whole of the Chakma Autonomous District Council;
- (3) They shall come into force at once.
- **2. DEFINITION:** In these Rules, except where it is expressly otherwise provided or the context otherwise requires:
  - (a) "Constituency" means such area which falls within the jurisdiction of a Village Council;
  - (b) "District" means the Chakma Autonomous District Council;
  - (c) "District Council" means Chakma Autonomous District Council;
  - (d) "Elector in relation to a constituency" means a person whose name for time being entered in the Electoral Roll;
  - (e) "Executive Committee" means the Executive Committee of the Chakma Autonomous District Council;
  - (f) "Executive Secretary" means the Executive Secretary of the Chakma Autonomous District Council;
  - (g) "Electoral Roll" means the Electoral Roll of a constituency of a Village Council and shall include the names of all persons who are entitled as voter;
  - (h) "Election" means an election to fill a seat in the Village Council;

- (i) "Local Administration Officer" means Local Administration Officer of the Chakma Autonomous District Council;
- (j) "Presiding Officer" means the officer appointed by the **State Election Commission** for conducting the election in the polling station and may include the Returning Officer if the **State Election Commission** directs that the same person shall perform the function of both Returning Officer and Presiding Officer.
- (k) "Returning Officer" means the Officer appointed by the **State Election Commission** for conducting the election to the constituency;
- (I) "Village" means Village or Villages declared to form a Village Council under sub-section (I) of section 3 of the Chakma Autonomous District Council (Village Councils) Act, 2003, by the Executive Committee.
- (m) "State Election Commission" means the State Election Commission as constituted for the state of Mizoram under provision of Part IX and Part IX A of the Constitution.

### 3. HOLDING OF GENERAL ELECTION:

- (a) All elections to the Village Councils shall be held under the provisions of these Rules and shall be conducted by symbol system and the symbols to be utilised for the purpose shall be those specified in Appendix-I of these Rules.
- (b) The Returning Officer for the election to the Village Council shall notify the name of constituency with the number of members fixed for each Village Council to be elected and nominated. The District Council may at any time, revise or modify this provision if necessary.
- (c) There shall be an Electoral Roll for every constituency for the election to the Village Councils, and may be revised by the **State Election Commission** from time to time.
- (d) The person whose name is included in the latest Electoral Roll for the election to the District Council shall be the elector to the election of the Village Council.
- 4. APPOINTMENT OF OFFICER: The State Election Commission shall appoint Election Officials as per provision of Section 3 (7) of The Chakma Autonomous District Council (Village Councils) (Amendment) Act, 2011.
- 5. DATE OF ELECTION: The State Election Commission shall by notification call upon all constituencies concerned to elect the number of members to be returned, and shall also appoint the date or dates simultaneously or consecutively according to convenience. The Returning Officer may, however, cause an election to be held on such date before or after the date appointed in respect of any constituency as a special case, when the appointed date cannot be observed due to some unforeseen inconvenience.

Provided that the change of date shall be notified to the constituency concerned by the Returning Officer at least seven days before the date so fixed for election.

### 6. APPOINTMENT OF NOMINATED MEMBER AND FILLING OF VACANCIES:

- (1) Nominated member in each Village Council as prescribed shall be appointed by the Executive Committee from amongst the persons qualified to become a Member of a Village Council according to these Rules. Provided, such person shall apply in the prescribed form informing his willingness to serve as Nominated Member of the Village Council to the Executive Committee or any other Officer appointed for such purpose by the Executive Committee. And such appointed Nominated Member shall hold office at the pleasure of the Executive Committee.
- (2) If any elected member is found to be disqualified after the election, the seat may be declared vacant by the Executive Committee, and be filled under the provision of these Rules.
- (3) A seat and a casual vacancy in the Village Council in respect of a nominated seat shall be filled by the Executive Committee by appointment in the same manner as prescribed in sub-rule (1) of this Rules.
- (4) A seat and a casual vacancy in the Village Council in respect of an elected seat shall be filled by bye-election.
- 7. PUBLICATION OF THE NAMES OF MEMBER OF VILLAGE COUNCIL: The name of members elected and those nominated for various Village Councils shall be published in the constituency as soon as may be after the election is over.
- 8. RETURNING OFFICER: It shall be the general duty of the Returning Officer at any Village Council election to do all such acts and things as may be necessary for proper conduct of election in the manner provided under these Rules and his decision shall be final.
- POWER OF THE STATE ELECTION COMMISSION: The State Election Commission may prescribe such forms as may be necessary for the conduct of election from time to time.

## CHAPTER-II CANDIDATES AND VOTERS

### 10. Qualifications for Elector:-

- Every person who is
  - a) a citizen of India who belongs to Scheduled Tribe;
  - b) a permanent resident of the respective Village Council;
  - c) not below the age of 18 (eighteen) years on the qualifying date;
  - d) not of unsound mind and does not stand so declared by any competent court, and
  - for time being, not disqualified for voting under the provisions of any law relating to corrupt or illegal practices or other offences in connection with election, shall be entitled to vote at any election to the Village Council.
- 2) No person shall be entitled to be registered in the electoral roll for more than one Village Council constituency.
- 3) For the purpose of these Rules, "qualifying date," as used in sub-rule (1) and in relation to the preparation or revision of every Village Council electoral roll under this chapter shall be the date that may be declared by the **State Election Commission** by notification from time to time.
- 11. ELECTORAL ROLL FOR VILLAGE COUNCIL: There shall be an electoral roll for every Village Council constituency for the election to the Village Council prepared in accordance with the rules hereinafter provided-
  - (a) The Electoral Roll of a Village Council constituency for the election to the Village Council prepared in accordance with the latest Electoral Roll for the election to the District Council, as and when revised, be the electoral roll for the purpose of the general election to the Village Council;
  - (b) There shall be a summary revision of the electoral roll for inclusion, deletion or correction of names in the electoral roll of the Village Council constituency preceding any election to the Village Council constituencies on such timeframe as may be decided and notified by the **State Election Commission**.
  - (c) If any difficulty or question arises as to the preparation or review of any electoral roll under these rules, the same shall be decided by the Returning Officer or other Officers appointed by the **State Election Commission** for the purpose, and his decision shall be final.

Provided that the entire process of publication of electoral roll should be completed on or before the date fixed for filing of nomination-papers for the Village Council election.

# 12. QUALIFICATION OF CANDIDATES FOR THE ELECTION AND SCRUTINY OF CANDIDATE:

- (a) Any person whose name is included in the Electoral Roll of the constituency and who is not otherwise disqualified under Section 4 of the Chakma Autonomous District Council (Village Councils) Act, 2003 may be a candidate for the election to the Village Council and shall inform the Returning Officer in writing in a form as prescribed along with a fee that may be fixed by the **State Election Commission** from time to times of his intention to do so, by a particular date to be notified in this behalf by the Returning Officer.
- (b) The scrutiny of candidature shall be conducted by the Returning Officer in the respective Village Council constituency on the date and time to be notified by him. The Returning Officer shall then examine the nomination papers and shall decide on all objections which may be made to any nomination and may, either on such objection or in his own motion after such summary inquiry, as he may think necessary, refuse any nomination on any of the following grounds:-
  - (i) that the candidate is not qualified to be elected to fill the seat under these Rules.
  - (ii) that the candidate or any proposer or seconder is not substantially identical with the person whose number or name appearing in the Electoral Roll as is given in the nomination paper as the number or name of such candidate, proposer or seconder.
  - (iii) that the signature of the candidate or any proposer or seconder is not genuine or has been obtained by fraud; Provided that the Returning Officer shall not refuse any nomination paper on the ground of technical defect, wrong spelling of name, and the like, and shall accept any nomination paper in respect of which he is satisfied that the candidate is qualified to be chosen to fill the seat and has been proposed and seconded by persons who are qualified to do so.

### 13. WITHDRAWAL OF CANDIDATURE AND REFUND OF SECURITY DEPOSIT:

- (a) The Returning Officer may accept the withdrawal of any candidature, before or after the security of the candidature, and refund the security deposit money on obtaining a receipt to that effect as prescribed.
- (b) The Security Deposit of all other contesting candidate shall be credited to the District Council fund according to established procedure in regards to District Council local receipt and the Local Administration Officer shall be responsible for the same.

- (c) The Security Deposit of the candidates other than those whose Security Deposit are forfeited as per provisions of Rule 16(a) of these rules shall be refunded on issuance of a sanctioning order by the **State Election Commission**.
- (d) On completion of the scrutiny of the nomination papers, the Returning Officer shall forthwith examine the symbols chosen by the candidate, and if such symbols are found to be in conflict with each other or with any symbols already assigned, he shall allocate the symbols in conformity, as far as possible with choices of the candidates, and, if necessary, by lot and his decision in this respect shall be final. Each candidate or his election agent shall, at the same time, be informed of the symbol assigned to him and shall be given a specimen thereof.
- (e) The Returning Officer shall endorse on each nomination paper, his decision of accepting or rejecting the same and, if the nomination paper is rejected, shall record in writing a brief statement of his reason for such rejection.
- (f) The scrutiny shall be completed, if possible, on the fixed day, and time for the nomination of the candidates but if it can not be completed on that day and time it may be adjourned to the following day or if the following day is holiday, to the next working day.
- 14. DEATH OF A CANDIDATE BEFORE POLL: If a candidate who has been duly nominated under these Rules dies after scrutiny of nominations and, before the commencement of poll, the Returning Officer /Asst. Returning Officer shall, on being satisfied of such death, countermand the poll in the constituency concerned and report the facts to the State Election Commission, and all proceedings with references to the election.
- **15. PUBLICATION OF VALID CANDIDATE LIST:** The Returning Officer or Assistant Returning Officer shall publish the valid list of candidate after the scrutiny and withdrawal of candidature.

### **16. FORFEITURE OF SECURITY DEPOSIT:**

(a) The Security Deposit of such candidate who is not elected and the total number of votes secured by him do not exceed one-sixth of the total votes polled shall be forfeited to the District Council. The Presiding Officer or the Returning Officer as the case may be, shall deposit all such money to the Local Administration Officer by making a list of such candidate in a form as may be prescribed.

- (b) The Local Administration Officer shall make a compilation of such money received from the different Presiding Officer or Returning Officer and shall cause, deposit of all such money to the Executive Secretary to be credited in the District Council Fund by making entry in a form as prescribed.
- 17. ELECTION SYMBOL: Each candidate shall select a symbol out of those prescribed in Appendix-I to represent him in the election and the election shall be conducted by symbol. The Returning Officer shall decide by lot, to which of these candidates exceeds that of the seat to be filled. The Returning Officer shall compile a list showing the names of the valid candidates and the symbols assigned to each candidate and publish in the manner he thinks fit and a poll shall be taken in the manner prescribed in these Rules.

# 18. WHEN NUMBER OF VALID CANDIDATES IS EQUAL TO THE NUMBER OF SEAT:

- (1) If the number of valid candidates in a constituency is equal to the number of seats to be filled, the Returning Officer shall forthwith declare such candidates to be elected to those seats in the Village Council uncontested.
- (2) If the number of valid candidates is less than the number of seats to be filled, the Returning Officer shall declare all such candidates to be elected and fill as many as those seats. The **State Election Commission** shall by notification, call upon the constituency to elect a person or persons to fill the remaining seat or seats, as the case may be, within such times as may be notified.

# CHAPTER-III VOTING

- **19. ARRANGEMENT OF VOTING:** There shall be only one and if necessary, more polling Station for each constituency. The Returning Officer or any Officer appointed by him shall make all arrangements for the conduct of the election.
- **20. ELECTION AGENT:** One election agent of a candidate is appointed in writing and submitted to the Returning Officer, who shall be admitted into the polling booth in case of the candidate absenting himself from the polling station.
- 21. NO VOTE BY PROXY: Every voter shall record his/her vote at the polling booth by him/her only and no vote by proxy or otherwise shall be accepted.
- 22. HOURS OF POLL: The Returning Officer shall fix the hours for polling vote.

- 23. BALLOT BOXES: Just before polling is started, the empty ballot boxes with their respective symbol and name of the candidates fixed on them shall be shown to the persons present at the polling station. The ballot boxes then be closed with an adhesive and wax sealing devices.
- 24. BALLOT PAPER: Each voter shall be given as many ballot papers as there are elected seats. The State Election Commission may direct that before the ballot papers are delivered to an elector at a polling station, such official marks as may be specified in this behalf, shall be given on ballot papers and the official marks so specified shall be kept secret.
- **25. RECORD OF VOTES:** Each voter shall record his vote by dropping only one ballot paper in each box containing the symbol assigned to the candidate of his choice.

Provided that for any reason a voter does not want to use his ballot paper, the voter concerned must return the same, which shall be cancelled and marked 'refused' on the counterfoil.

Provided further that if an elector gives more than one vote to any one candidate, then at the time of counting of votes, not more than one of the votes given by him to such candidate shall be taken into account and all other votes given by him to such candidate shall be declared void.

- 26. HELPING OF VOTER: If owing to blindness or other infirmity any elector is unable to read the symbol on the ballot box or is physically incapable of casting the ballot paper into the ballot box, the Presiding Officer will ascertain from the elector the candidate or candidates he desires to vote for and shall put the ballot paper or papers in the ballot box or boxes of such candidates in accordance with the wishes of such elector. The Presiding Officer shall have this done with as much as possible and shall have a record of such instances.
- 27. SPOILT OF BALLOT PAPER: If the ballot paper happens to be spoilt before it is used due to any reason, another ballot paper may be obtained surrendering the spoilt ballot paper which shall be cancelled with the counterfoil.
- 28. SUSPENSION OF VOTING: If due to any reason beyond control, the polling of votes has to be stopped resulting in the dispersion of the voters and the candidates, the Presiding Officers within the hours prescribed and before all the votes polled, the polling shall be suspended and ballot boxes be closed by pasting with an adhesive and wax sealing devices till they are re-opened when polling is continued as decided by the Presiding Officer present.

29. CLOSING OF BALLOT BOXES AFTER POLL: As far as practicable, after the closure of the poll, the Presiding Officer shall, in presence of candidate or their agents who may be present, close the ballot boxes and seal them and shall retain the ballot boxes in safe custody until the commencement of the counting of votes.

# CHAPTER-IV COUNTING OF VOTES

- **30. COUNTING OF VOTES:** Counting of votes shall be taken up as soon as possible after the closure of the poll and the Returning Officer may appoint any person as may be necessary to assist him in the counting of votes.
- 31. AUTHORISED PERSON AT THE COUNTING OF VOTES: No person shall be allowed to be present at the counting of votes except the Returning Officer and such other persons as he may appoint to assist him in counting the votes, the candidates, election agents, as may be required, authorised in writing by the candidate shall have the right to be present at the time of counting.
- 32. SUSPENSION OF COUNTING OF VOTES: If due to any reason beyond control, the counting of votes has to be delayed for any period resulting in the dispersion of candidates and the election staff from the booth or place appointed instead, the ballot boxes shall be closed by pasting an adhesive and wax sealing devices. The boxes shall be reopened at the next counting of votes held.
- **33. DISPOSAL OF COMPLAINT:** The result of the election shall be announced by the Returning Officer as soon as possible after the counting of votes is finished. Any protest against the time of announcement of the result, the Returning Officer shall explain the circumstances connected with the complaint.
- **34. EQUAL OF VOTES:** In the case of equal of votes, membership shall be decided by drawing of lots.
- **35. PUBLICATION OF ELECTION RESULT:** The list of the candidates elected shall be published in the constituency.

## CHAPTER-V ELECTION PETITION

- 36. SUBMISSION OF ELECTION PETITION: A petition challenging the validity of any election may be submitted by a candidate and no one else to the State Election Commission or any officer appointed by it for the purpose within 15 (fifteen) days after the declaration of the election results by the Returning Officer of the constituency concerned, attaching to the petition, an official receipt of the District Council showing that a deposit of Rs. 300/- as security for cause of hearing of the petition has been made. Such deposit shall be forfeited to the District Council in case the petition fails. If, however, the petition succeeds, the deposit shall be refunded. Unless such petition is withdrawn within a fortnight, the security deposit shall be forfeited to the District Council and be credited to District Council fund.
- 37. DISPOSAL OF ELECTION PETITION: The *State Election Commission* shall constitute an Election Tribunal to hear and dispose of all election petitions. The Tribunal shall report its findings and decisions to the *State Election Commission* where upon the *State Election Commission* shall notify the decision of the Tribunal.

### CHAPTER-VI CORRUPT PRACTICES

38. CORRUPT PRACTICES: The following shall be deemed to be corrupt practices for the purpose of the election to the Village Council: (1) Bribery (2) Undue influence (3) Personating (4) Removal of ballot papers, (5) Publication of false statement and (6) Use of or appeal to religious and national symbols as defined in Chapter XX of the Chakma Autonomous District Council (Constitution, Conduct of Business etc.) Rules, 2003.

## CHAPTER - VII ELECTORAL OFFENCES

- **39. PUBLIC METING:** No person shall convene, hold or participate in any public meeting or canvas for self or for any candidate on the date on which poll is taken for election to the Village Council.
- **40. MAINTENANCE OF SECRECY:** Every Officer, clerk or agent or other person who performs any duty in connection with the recording or counting of votes at an election, shall maintain the secrecy of the voting.

- **41. PROHIBITION OF INTERFERENCE WHILE POLLING:** No person shall interfere in any way with the work of the Returning Officer or other Officers employed for the conduct of election to Village Council.
- **42. CONTRAVENTION OF ANY PROVISION:** Any person who contravenes any of the provision of this Rules 39 to 41 shall be punishable with a fine which may extend to Rs. 500/- (Rupees five hundred).

# CHAPTER-VIII POWER OF RETURNING OFFICERS

- **43.** No Civil Court shall have jurisdiction to question the legality of any action taken or any decision given by the Returning Officer or by any other person appointed under these Rules in connection with an election.
- **44. REPEAL AND SAVINGS:** The Pawi-Lakher Autonomous Regional (Election to Village Councils) Rules, 1954 as amended and applicable to the Chakma Autonomous District Council is hereby repealed.
